Medical providers are obliged to report vaccine injuries (adverse events) to the authorities.

**Alberta Public Health Act ("PHA"):**

Paragraph 18.4 of the PHA requires health practitioners to report adverse events following immunization.

**Alberta Immunization Regulation 182/2018 ("IR"):**

Subsections 5(1) and 6(1) require health practitioners to report adverse events within 3 or 4 days.

## Informed Consent

is the professional and legal responsibility of the provider to obtain prior to vaccination.

The **Informed Consent** process involves:

- Providing all relevant information to the patient/client
- Ensuring all known risk and adverse event information is understood by the patient/client
- Voluntarily agreeing to participate

## Risk vs. Benefits of Covid-19 Vaccine

On March 1, 2022, by court order, the FDA released the *Pfizer Post-Authorization of Adverse Event Reports* document, representing the initial three (3) months of the COVID-19 vaccine rollout from 01-Dec-2020 to 28-Feb-2021. The following summarizes the outcomes

Overall Adverse Events provides a summary review of cumulative cases in the first 3 months after the Covid-19 vaccine rollout:

- 158,893 adverse events resulted from 42,086 reported cases
- Of the 42,086 case reports:
  - 1,223 list DEATH as the outcome
  - 9,400 list UNKNOWN as the outcome (22% of the total 42,086 cases)
  - 11,361 list NOT RECOVERED at the time of the report (unknown final outcomes)
- Majority of Adverse Events include:
  - nervous system disorders (25,957), musculoskeletal/connective tissue disorders (17,283)
  - gastrointestinal disorders (14,096)
  - cardiovascular, anaphylaxis, facial paralysis, COVID-19 infection, dermatological, hematological, hepatic and autoimmune conditions
- 1291 Adverse Events of Special Interest, include current illnesses:
  - Respiratory Syncytial Virus (RSV), influenza, pneumonia, SARS-Covid

### Pregnant and Breastfeeding Women

No clinical trials with pregnant and breastfeeding women were conducted and none finalized to date. No safety data is available for this vulnerable group of patients.

Pfizer's *Post-Authorization of Adverse Event Reports* summarizes 270 mother case outcomes of pregnant women who received the BNT162b2 vaccine between 01Dec2020 to 28Feb2021 (pg. 12).

Of the 270 mother cases,

- 238 with 'no outcome'
- 5 with 'pending outcome'
- 28 DEATHS from 29 revealed outcomes
- only 1 revealed LIVE BIRTH
